CONSENT AND ACKNOWLEDGMENTS IN TERMS OF THE PROTECTION OF PERSONAL INFORMATION ACT 2013 (POPI)

This section sets out how personal information will be collected, used and protected by Metrobus SOC hereinafter referred to as "Metrobus", as required by the Protection of Personal Information Act. 1. What is personal information?

2. What is the purpose of the collection, use and disclosure (the processing) of personal information?

Metrobus is legally obligated to collect, use and disclose personal information for the purposes of:

- Reporting initiatives to the City of Johannesburg Municipality:
- reporting to National Treasury all contracts awarded;
- obtaining information related to Tax Compliance information from SARS;
- Verifying information on the National Treasury database of defaulters;
- evaluating and processing applications for registration on the database;
- · compiling statistics and other reports;
- providing personalised communications:
- •for the purpose of audits
- complying with the law; and/or
- •for a purpose that is ancillary to the above. Personal information will not be processed for a purpose other than what is identified (the purpose) above without obtaining consent beforehand.
- 3. How will Metrobus process personal information?

Metrobus will only collect personal information for the purpose as stated above. Information will be collected in the following manner:

- directly from the individual;
- •from service providers who provided with services or goods to Metrobus;
- •from Metrobus own records relating to previous supply of services or goods; and/or
- •from a relevant public or equivalent entity.
- 4.To whom will personal information be disclosed?

The personal information may be disclosed to other relevant public or other entities on whose behalf we act as intermediaries, other third parties referred to above in relation to the purpose or who are sources of personal information,





service providers such as professional bodies who operate across the borders of this country (transborder flow of information) where personal information must be sent in order to provide the information and/or services and/or benefits requested or applied for. In the event of another party/ies acquiring all of or a portion of Metrobus' mandate or functions, personal information will be disclosed to that party but they will equally be obliged as we are, to protect personal information in terms of this policy and the law.

5. Consent and Permission to process personal information:

I hereby agree with the policy and provide authorisation to Metrobus to process the personal information provided for the purpose stated:

- •I understand that withholding of or failure to disclose personal information will result in Metrobus being unable to perform its functions and/or any services or benefits I may require from Metrobus.
- •Where I shared personal information of individuals other than myself with Metrobus I hereby provide consent on their behalf to the collection, use and disclosure of their personal information in terms of this personal information policy and I warrant that I am authorised to give this consent on their behalf.
- •To this end, I indemnify and hold Metrobus not responsible in respect of any claims by any other person on whose behalf I have consented, against Metrobus should they claim that I was not so authorised.
- •I understand that in terms of POPIA and other laws of the country, there are instances where my express consent is not necessary in order to permit the processing of personal information, which may be related to police investigations, litigation or when personal information is publicly available.

6. Rights regarding the processing of personal information:

Should the withdrawal of consent result in the interference of legal obligations, then such withdrawal will only be effective if Metrobus agrees to same in writing. Metrobus specifically draws to the attention that the withdrawal of consent may result in it being unable to provide the requested information and/or services and/or financial or other benefits.

REQUEST FOR A QUOTATION - Provision of Waste removal services as follows: -

The scope of works requires the Contractor to undertake collection and disposal of hazardous waste from Metrobus sites:

- Roodepoort
- Milpark and
- Village main

All collections will be defined and instructed by the Delegated Depot Manager as required. The types of hazardous waste encountered regularly by the Employer include:

- Oil and fuel wastes including waste hydraulic/engine/gearbox/lubricating oils, bilge, waste liquid fuels e.g. Waste
 oil and fuel Filters, oil contaminated water from steam cleaner, and sludge.
- Cleaning of oil spillages which include assessing the spill size and location, containing the spill using booms or
 absorbent materials, removing visible oil with appropriate techniques like skimming or absorbent pads, properly
 disposing of collected oil and contaminated materials, cleaning affected areas, monitoring for environmental
 impact, and documenting the entire clean-up process; all while adhering to safety protocols and relevant
- The supplier will be required to use a super-sucker to suck the sludge (Contaminated oil mixed with water and other chemicals)

Specific Health & Safety Hazards

In addition to the requirements above of the Service Information, the Contractor is informed of the following potential hazards:

1. Hazardous Waste

Hazardous waste collection, transport and disposal will involve manual handling and exposure to hazardous substances. The Contractor shall have procedures to ensure that their staff uses appropriate PPE, equipment and hygiene techniques to ensure their health.

Hazardous waste collection and disposal will often be in areas where slips, trips and falls are more likely to occur. The Contractor shall ensure that all work areas are continually monitored for trip hazards.

3. Sharps Hazard

The Contractor is likely to encounter Sharps during this work activity and is to ensure all 'sharps', including syringe needles or razor blades, are removed immediately and deposited into an approved 'sharps' container and then disposed of in accordance with current legislation and best practice. Where there is a frequent and regular occurrence of syringes

Requirements for the waste management contractor

- Contractor should be a holder of waste management licenses issued by the Agriculture and Rural Development (Pollution and Waste Management Unit) in terms of the National Environmental Management Waste Act(Act No.59 of 2008).
- Supplier will be required to provide a disposal certificate after removal of waste.

Evaluation Criteria
