



Metrobus Erratum

This erratum is issued in relation to Tender NO: ICT02-2024/2025 PROVISION FOR A PANEL OF SERVICE PROVIDER(S) FOR THE SUPPLY, DELIVERY AND CONFIGUARATION OF LAPTOPS AND DESKTOPS AND ACCESSORIES FOR A PERIOD OF 36 MONTHS TO METROBUS ON AS AND WHEN REQUIRED BASIS.

1. Amendment of Evaluation criteria (Functionality):

The tender document that was issued on the 11th of April 2025

The erratum is issued as follows:

EVALUATION CRITERIA

(FUNCTIONALITY) ERRATUM 1 AMENDED EVALUATION CRITERIA

Bidders will be evaluated in accordance with the area of specialization indicated above.

NOTE: For purpose of comparison and in order to ensure a meaningful evaluation, bidders must submit detailed information in substantiation of compliance to the evaluation criteria mentioned (e.g. details of relevant previous work undertaken, letters from previous /current clients, proof of ownership of manufacturing facility, etc.) failure to submit the requested documents will result in the bidders not scored on the criteria.

Minimum Required Score for functionality is: 60 points out of 100 points and any bidder scoring less than 60 points will not be considered for further evaluation. Service Providers that qualified in terms of the functionality cut-off points of 60 points will then be evaluated in terms of price and preference points.

Reference letters that are not signed and dated will not be acceptable.
